

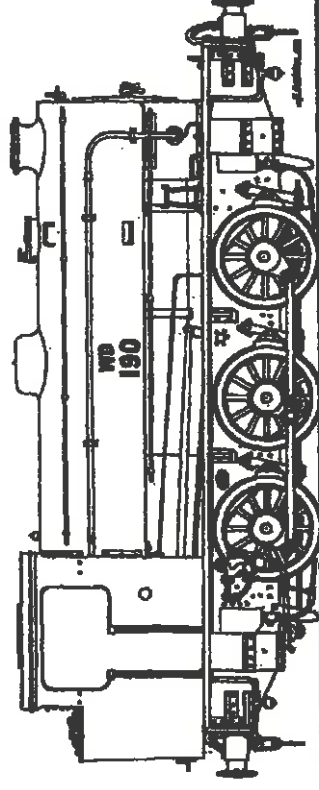

## Notes on Gift Aid:

1. You must pay an amount of income tax and/or capital gains tax at least equal to the tax that CVRPL reclaims on your membership subscription and donation in the tax year.
2. CVRPL will treat all your membership subscriptions and donations as Gift Aid donations until you notify us otherwise. You can cancel this declaration at any time by notifying the membership secretary.
3. If in the event your circumstances change and you no longer pay tax on your income and capital gains equal to the tax that CVRPL reclaims, you must cancel your declaration.
4. If you pay tax at a higher rate you can claim further tax relief in your Self-assessment Tax return.
5. Please notify the membership secretary of any change of name or address.
